- 1- 95% of PT CG Power Indonesia, a company that manufactures electric power in Indonesia, amounting to 10,000 megawatts. The company provides maintenance services over the life of the transformers in addition to the establishment of transformer substations. The company is known to export its products to multiple countries in the region, including: Malaysia, New Zealand, Australia, Vietnam and the Philippines
- 2- 100% of Validus Engineering PVT LTD, the leading manufacturer of power transformers in Pakistan. El Sewedy Electric plans to introduce its technology for power inverters to boost the company's growth, with a production capacity of 5,500 MVA. The company enjoys a long-standing reputation since its establishment in the local market.

These latest additions to Elsewedy Electric's business portfolio will bring Elsewedy Electric's total transformer factories to six and will more than double the annual production capacity to 30,000 MVA. 
