The minutes of the General Assembly Meeting which was held on 17/April/2024 have been reviewed.</p> <p>3. The minutes of the second Audit Committee Meeting for the year 2024 which was held on 01/May/2024 have been reviewed.</p> <p>4. The Corporation's financial statements for the first quarter of the fiscal year 2024 and the external auditor report have been considered.</p> <p>5.
