Summary of the company's performance for the last fiscal year:

1. Total assets increased from AED 2.85 billion to AED 2.91 billion. The movement is due mostly to better liquidity position of the Corporation, as cash and short-term deposits increased compared to last year.
2. Cash and short-term deposits increased from AED 358.49 million to AED 433.50 million, after repayment of term loans of AED 35.68 million during the year.
3. Share Capital remained at AED 899.03 million during the year.

4. Revenue for 2024 reached AED 698.56 million compared with last year of AED 669.20 million.
5. Net operating profit for the year 2024 was AED 99.84 million or 14.29% from gross revenues amounting to AED 698.56 million, compared to AED 96.62 million or 14.44% from gross revenues amounting to AED 669.20 million last year, due to increased profit from the Corporation's hotel segment and retail services.
6. Net profit for the year 2024, after provision for income tax expense of AED 5.95 million, was AED 74.03 million compared to AED 68.08 million of 2023 or 8.74% increase. There was no provision for income tax expense for 2023.
7. The abovementioned preliminary results for the year ended 31 December 2024 are subject to finalization.
