### 7-Summary of the company's performance for the last fiscal year.

During the last few months Fidelity United has gone through a massive restructuring exercise under the leadership of the new management. Good progress has been achieved so far however there is a lot more which is in the works and expected to be completed during 2025. The key focus has been on achieving superior underwriting results, keeping sustainable growth in perspective. This will help to create portfolio optimization by expanding the distribution through leveraging new products and enhanced connectivity with the business partners.

I am pleased to share that the Audit qualification on Q3 2024 Financial Results has been resolved and in accordance with the best industry practices, Fidelity United has accounted for the Reinsurance Adjustments, including the major ones emanating from the 2024 adverse weather events. This will ensure that Fidelity United is ready to begin the year 2025 without any legacy issues and with a fresh and positive outlook.



Apart from the above, Fidelity United incurred a few large losses pertaining to our commercial business during Q4 2024 causing an adverse effect on the financial results. Due to the above factors, Fidelity United incurred an after tax loss of AED 66.2m for the year ended December 31, 2024 as compared to AED 17.4m for the prior year.
