



Overview of Projects Awarded During the Current Year (2025)

Figures 1&2 show that the number of projects awarded in January was the highest at 15 projects, while as for the financial value, February was the highest with more than 8 Billion SAR.

Number of Projects for 2025




Figure 1: Number of projects awarded in the first 3 months of 2025.




Figure 2: The value of projects awarded in the first 3 months of 2025.



Projects awarded to Contractors in March 2025 by Industry

According to SCAVO (construction projects tracking platform), a total of 5 projects were awarded in March 2025 with a combined value exceeding 5 billion SAR. The Building and Construction sector accounted for 60% of the total number of projects with 3 projects. And for the financial value, the Power & Water sector was the highest with more than 3 billion SAR representing 70% of the total projects values for March 2025.




Figure 3: Percentage of awarded projects distributed by sector.

Regional Distribution of the Projects Awarded During March 2025

Eastern Province accounted for the most awarded projects in March, with 3 projects Accounted for 60%




Figure 5: The Values of projects distributed by region.

Figure 5 shows the projects' values by region. It indicates that Riyadh Province is the leading region in terms of the total value of projects, with value exceeding 2.7 billion SAR.

The Expected Project Completion Year for the Projects Awarded During March 2025

It is expected that 4 of the projects awarded in March 2025 will be delivered within 2027 which accounted for 80% of the total projects, while 1 project will deliver within 2029.

The Top Five Project Owners, Based on the Value of Their Awarded Projects in March 2025

Saudi Electricity Company (SEC) is the top project owner in March in terms of the Value of projects, with value exceeding 2 billion SAR. while as for the number of projects all companies had an equal number of projects, with one project assigned to each company.




Figure 7: The top five project owners, based on the value of their awarded projects in March 2025.
