

## Operating Revenues Index increases by 10.2% in March 2026 compared with the same month of the previous year

Preliminary results indicated a 10.2% increase in the Operating Revenues Index compared with the same month of the previous year (March 2025). On a monthly basis, the Index increased by 8.1% compared with February 2026. Issued building permits recorded an annual decrease of 0.7% compared with the same month last year, and a monthly decrease of 11.3% compared with February 2026.

### Operating Revenue Index in March 2026

The Operating Revenues Index increased by 10.2% year-on-year, supported by an increase in manufacturing activities by 4.0% mining and quarrying activities, which increased by 25.5% and increases in wholesale and retail trade and repair of motor vehicles activities by 4.6% and increases of 4.8% and 17.6% in construction activities and financial and insurance activities, respectively.

On a monthly basis, the Operating Revenues Index increased by 8.1% supported by an increase in manufacturing activities by 4.4% and mining and quarrying activities which increased by 38.6% and a wholesale and retail trade and repair of motor vehicles activities by 0.2% and increased of 2.6% and 0.6% in financial and insurance activities and information and communication activities, respectively.

Figure 1. Operating Revenues Index and annual change rates

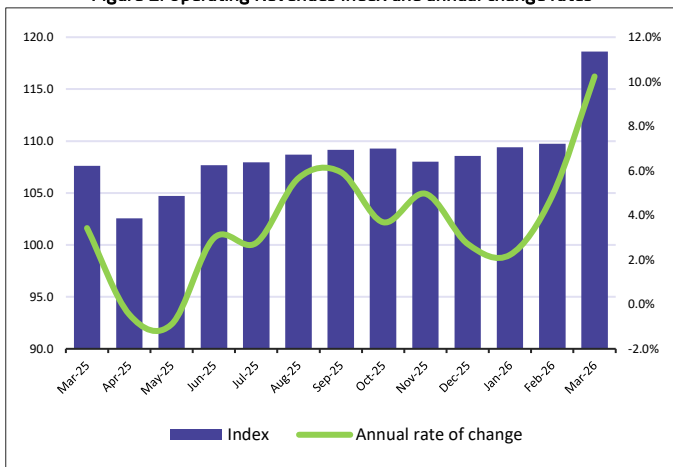
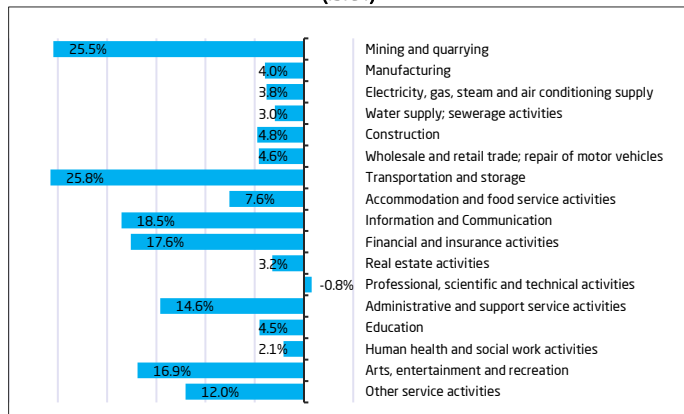


Figure 2. Annual change rate for Operating Revenues Index by Economic Activities (ISIC4)



### Employees Compensation Index

The Employees Compensation Index recorded an annual increase by 10.0% supported by an increase in manufacturing activity by 9.9% construction activities by 7.9% wholesale and retail trade and repair of motor vehicles and motorcycle activities by 10.4% and mining and quarrying activities and financial and insurance activities by 0.7% and 14.4%, respectively.

On a monthly basis, the Employees Compensation Index showed an increase of 0.4% supported by an increase in construction activities by 0.3% wholesale and retail trade and repair of motor vehicles and motorcycle activities by 0.4% mining and quarrying activities by 0.4%, and financial and insurance activities and transportation and storage activities by 0.4% and 3.6%, respectively.

Figure 3. Employees Compensation Index and annual change rates

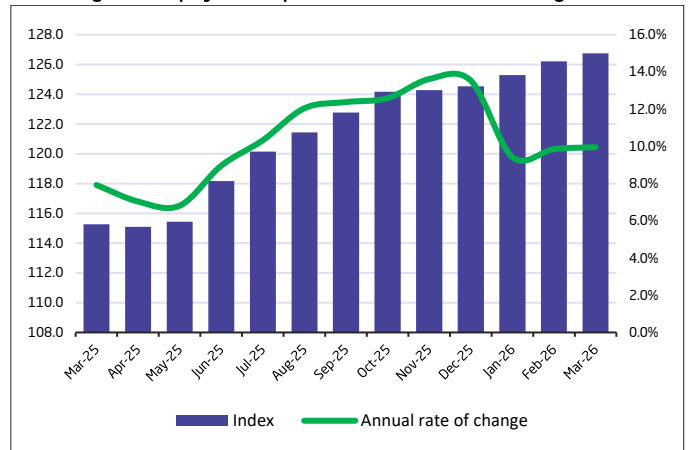
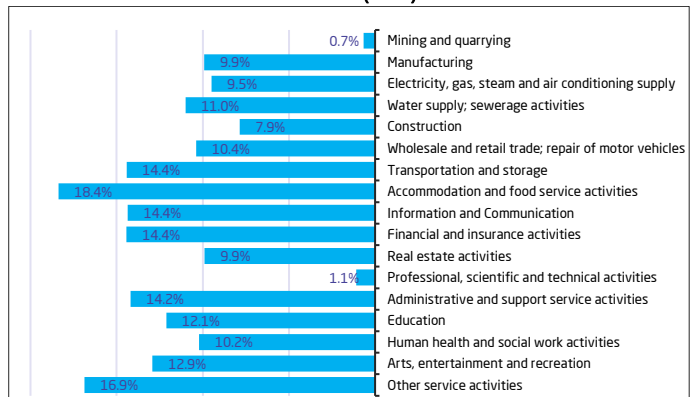


Figure 4. Annual change rate for Employees Compensation Index by Economic Activities (ISIC4)

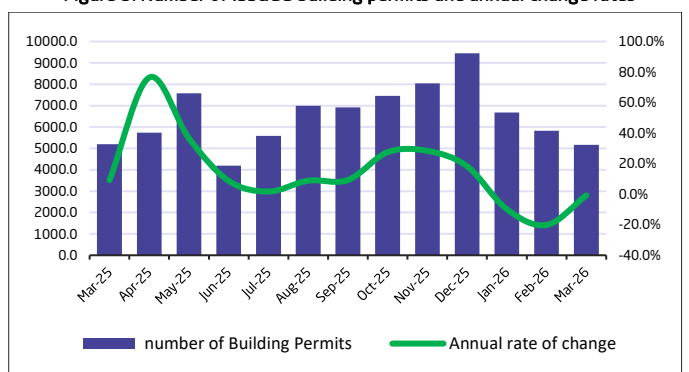


### Issued building permits

During March 2026, the number of issued building permits decreased by 0.7% compared to the same month of the previous year, declining from (5,201) permits in March 2025 to (5,162) permits.

Compared to February 2026, the number of issued building permits also decreased from (5,821) permits to (5,162) permits, a decrease of 11.3%
